CMI's 2023 Compliance Checklist

OSHA Annual Requirements

Complete within a 12-month period (no specific deadline)

Access to Employee Exposure and Medical Records
(1910.1020): Annual review of requirements with employees
Automatic Sprinkler Systems (1910.159): Annual drain flow testing
Bloodborne Pathogens (1910.1030): Annual training and annual review of exposure control plan
Employee Alarm Systems (1910.165): Annual testing of supervised employee alarm systems
Fixed Extinguishing Systems, General (1910.160): Annual inspection of fixed systems, and annual review of training for employees designated to inspect, maintain or operate such systems
Fixed Extinguishing Systems, Dry Chemical (1910.161): Annual sampling of dry chemical supply
Fire Brigades (1910.156): Annual training for fire brigade members
The Control of Hazardous Energy (Lockout/Tagout) (1910.147): Annual inspection of each energy control procedure

Hazardous Waste Operations and Emergency Response (HAZWOPER) (1910.120): Annual training updates for HAZWOPER employees
Occupational Noise Exposure (1910.95): Annual audiometric testing and training
Occupational Exposure to Hazardous Chemicals in Laboratories (1910.1450): Annual review of the Chemical Hygiene Plan effectiveness
Process Safety Manager of Highly Hazardous Chemicals (1910.146)
Permit Required Confined Spaces (1910.146): Review of cancelled permits within one year after entry, and annual practice of rescues for employees performing entry rescue operations
Portable Fire Extinguishers (1910.157): Annual awareness training, and annual maintenance checks of portable extinguishers
Respiratory Protection (1910.134): Annual training and fit testing for respirator users
Stand Pipe and Hose Systems (1910.158): Annual inspection of hose systems
